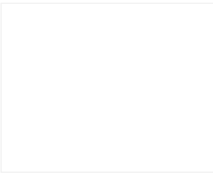

_____ I understand that the outdoor portion of the advanced program may take place in a small group setting at one of the local dog parks, which will provide optimum results for both the dog and the owner

_____ I understand that my account must be paid in full prior to or at the first training session and there will be no refunds.

_____ I understand that I am responsible for the outcome of my dog. I understand that following instructions as laid out by the 'Streetsmartk9' trainer will give me the optimum results. I am responsible for reading any literature provided by Streetsmartk9 for training or any tools needed in training. I realize that I have hired Streetsmartk9 as professionals to determine which tools are needed to help me train my dog to my expectations.

_____ I also understand that the remote collars are not to be left on unattended or overnight and I will read the collar instructions as provided by the manufacturer.

_____ I hereby expressly agree to indemnify, defend, and hold harmless 'Streetsmartk9', its officers, directors, employees, agents, volunteers and assigns for any claim arising out of or incident to my participation in the program.

_____ I understand that my dog is _____ dog aggressive, and/or _____ people aggressive, in which case I agree to use a muzzle during the training sessions. 'Streetsmartk9' has successfully trained many aggressive dogs, but there are no guarantees that aggression will disappear with training, so it is the owner's responsibility to muzzle the dog and keep the dog out of potential problem situations at all times, not just during training session.

Services. Streetsmartk9 Dog Training (the "Trainer") shall provide dog training services and equipment to Client pursuant to the program and on the terms set forth under Training Program/Terms below. The Training Program shall include the provision of one electronic training collar with transmitter ("Equipment"), and individual instruction to Client on the use of the equipment and methods of training the pet. If for any reason Client decides not to continue with the training, Trainer will purchase Equipment back for fifty percent (50%) of the original purchase price.

Indemnification/Liability. Client is responsible for the control, conduct and training of the Pet. Client is solely liable for any injury to persons or damage to property caused by the Pet. Client holds harmless and shall indemnify and defend Trainer from any and all injuries or damage caused by the Pet whatsoever. Client agrees that although Trainer can provide equipment and instruction for the training of the Pet, Trainer does not maintain control of the Pet, and Client is responsible for the successful training, control and conduct of the Pet at all times. If the Pet is aggressive, Client shall use a muzzle during all training sessions and Client shall be responsible for avoiding potentially problematic situations. Client shall follow all instructions for the Equipment and shall not leave the Equipment on the Pet unattended or overnight.

Results. All dogs have different temperaments and their owners vary in ability and willingness to follow the Program; therefore, results will vary. At the conclusion of the private sessions, Trainer will have Client demonstrate the training skills learned by the Pet. These skills shall include obedience to certain verbal commands and response to proper use of the Equipment. If Client follows the training instructions provided as shown at lessons, and at the conclusion of the Program the Pet fails to perform the skills required, at Client's option, Trainer will continue to work with the Client and Pet at no extra charge. No refunds will be given on any training after the first lesson has been taken

Images. Trainer may photograph and/or video tape training sessions for future use in training, advertising or other purposes. Client consents to Trainer's use of images of Client and the Pet in such manner.

Return check fee are paid in full. Should collection efforts become necessary, Trainer may recover all costs of collection, including reasonable attorney fees.
